 Subject: QVF Voter Registration List for the General Election

Enclosed is your bar coded QVF PRECINCT LIST for the November 6, 2018 General Election.

**Upon verification of the voters photo identification** please read and follow these instructions *carefully*:

1. **Highlight the bar code** in yellow next to each voter's name who voted. \*
2. If an error is made, please highlight over the yellow with blue. \*\*
3. If the voter, on whose name the mistake was made, arrives to vote, highlight their **name** in yellow rather than the bar code. \*\*\*
4. Please **do not make any other marks** near the bar code.
5. If there is **no bar code** for a voter, this means we need his/her Driver's License Number. If the individual appears at the polls to vote, please write the DL # in the blank space, then highlight it in yellow.
6. Be sure you acquire any Verify or Challenged Information **BEFORE you issue a ballot**.
7. An explanation for the Verify and Challenge Codes and other abbreviations are listed on the next page.
8. If you are unable to locate a potential voter in the QVF Precinct List, you must ask the person if they registered prior to the last day to register (Oct. 9), **and** if he/she has voted in an election since registering. If he/she did register before the deadline, has a receipt as proof, and has not voted in a previous election since registering, ask him/her to complete an Application, surrender their receipt, and allow him/her to vote.  
 If he/she did register on or before Oct. 9, but does not have a receipt, and has not voted in a previous election since registering, call the local clerk who will check the statewide look-up. If given the 'go ahead' by the local clerk, instruct him/her to complete the Affidavit under oath, provide proof of identification and complete the Application. Follow the Challenged Ballot procedure.
9. Do not allow a person who said they previously voted here, to vote... **there is a reason they can not be located on the Precinct List** (contact the local clerk).

It is very important to return this voter registration list with your election results (the #1 and #2 Envelopes) to the Local Clerk **immediately** upon completion with your unofficial results; **do not** seal this material in the ballot container. If it hasn't already, the history of electors who voted this election will be updated by the local clerk immediately after the election.
